In addition, the following shall be added as a new second sentence to Section 4.05(a): "In addition, upon the successive sale of each Lot to an Owner who individually or through tenants or assigns occupies a Lot, a Special Assessment payable by said Owner in the amount of \$400.00 shall be collected at the Closing of such sale for the benefit of the Association."
