- d) Capital Entrance Lighting. Formal bids are being accepted to install accent lighting to match the Senator's Ridge entrance. This is being considered for safety reasons as well as bringing uniformity to both entrances.

- a) Met with social committee chairperson and reviewed 2019 social event calendar and budget proposal. Event calendar and budget were unanimously approved.
- b) Reviewed two 2019 pool contract proposals. There were still some concerns to be addressed that All In One will have addressed by the March meeting.
- c) Adding additional cameras to blind spot areas of the amenities was unanimously approved.
- d) All In One has asked for volunteers to serve on the grinder system committee. To date only homeowner has volunteered. Tabled to March meeting.
- e) Pool furniture repair was unanimously approved. Furniture is currently out for repair.
- f) Multiple bids for pool repairs were reviewed and a contractor was unanimously approved. Pool repairs will begin soon.
- g) Capital accent lighting bids are pending. Tabled to March meeting.
- h) Capital entrance gate repairs have been completed.
